Section 4 First Aid

EMERGENCY OVERVIEW

DANGER. Harmful if swallowed. Causes severe skin burns and eye damage. May cause respiratory irritation.

EYES: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. Immediately call a poison center or a physician.

SKIN: Take off immediately all contaminated clothing and wash it before reuse. Wash with plenty of soap and water/shower. If skin irritation persists get medical attention.

INHALATION: Remove person to fresh air and keep comfortable for breathing. Immediately call a poison center or a doctor.

INGESTION: Rinse mouth. Do not induce vomiting. Seek medical attention immediately.

Suitable fire extinguishing media:

Use water spray, fog or foam.

Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.
